## RENVILLE COUNTY COMMISSIONERS' PROCEEDINGS FOR THE MONTH OF FEBRUARY 2021

#### **FEBRUARY 2, 2021**

Board convened at 9:00 a.m. Present: Chairman Robert Marmon, Commissioner Arnold Langehaug and Commissioner William Stanley.

Sean Mattern, Road Supervisor, met with the Board. The Volvo truck has been repaired. The crew is working on rust spot repairs on the sanding trucks. The seat needs to be replaced in the Volvo truck.

Diana Krause, Tax Director, discussed the 2021 agriculture land values. The County is within the acceptable range set by the State. Moved by Comm. Langehaug, second by Comm. Stanley to have a one percent increase in agriculture land values for the 2021 tax year. Motion carried by unanimous vote of aye.

Moved by Comm. Stanley, second by Comm. Langehaug to appoint Guy Solemsaas to the Renville County Water Resource Board. Motion carried by unanimous vote of aye.

County Sheriff, Roger Hutchinson, met with the Board. He reported the 2020 statistics for his department. They responded to 1,710 calls for service last year. Sheriff Hutchinson has hired Kyle Brown to fill the deputy sheriff position opening. Kyle will need to attend the Academy in June. He will be living in Mohall. The new radios are installed and working in all the patrol vehicles. Deputy Donohue will be training for the School Resource Officer position in March.

Moved by Comm. Stanley, second by Comm. Langehaug that the patrol vehicle bids be opened. Motion carried by unanimous vote of aye. Two bids were received, one for \$3,007.00 from Roger Hutchinson and one for \$1,600.00 from Yousef Dabbagh. Moved by Comm. Langehaug, second by Comm. Stanley to accept the bid from Roger Hutchinson. Motion carried by unanimous vote of aye.

Moved by Comm. Langehaug, second by Comm. Stanley that the Equipment Rental Bids be opened. It was noted that two bids were received in a timely manner and accompanied by the required certificate of insurance and contractor's license. Qualifying bids were received from: Sundre Sand & Gravel and Farden Construction. Moved by Comm. Stanley, second by Comm. Langehaug to accept these bids. Motion carried by unanimous vote of aye.

Correspondence addressed to the Board's attention was reviewed and discussed. January payroll and officers reports were reviewed and filed.

The Board received notice from Paul Benning, NDDOT, that funds are available from the CARES Act for road maintenance. The County's share is \$46,885.93 and must be obligated by September 30, 2024. The Board will use the funds on a future road project.

Moved by Comm. Stanley, second by Comm. Langehaug to void check #138432, in the amount of \$19.85. The check was written August 18, 2020 to Verizon Wireless. It is a duplicate payment. Motion carried by unanimous vote of aye.

Moved by Comm. Langehaug, second by Comm. Stanley that the minutes of January 2021 be approved as presented. Motion carried by unanimous vote of aye.

Auditor LeAnn Pollman presented information concerning pledge of securities from Citizen's State Bank and First Western Bank. Moved by Comm. Langehaug, second by Comm. Stanley that the pledge of securities report be accepted as presented. Motion carried by unanimous vote of aye.

Moved by Comm. Langehaug, second by Comm. Marmon to approve the Beer & Liquor licenses for the Country Mouse Bar/Karma Convenience Stores for the 2021 season. Motion carried by unanimous vote of aye.

Moved by Comm. Stanley, second by Comm. Langehaug to approve the Operations and Maintenance Agreement with the ND Game & Fish Department for the years 2021 through 2025. The agreement includes a grant for \$3,500.00 per year for maintenance of the fish cleaning station at the Mouse River Park. Motion carried by unanimous vote of aye.

Renae Johnson, 9-1-1 Coordinator discussed the 9-1-1 dispatch fee due to Bottineau County. The County pays Bottineau County \$1.05 per phone line for a dispatch fee. The amount due to Bottineau County is \$50,416.80 for the period of August 2019 through December 2020. The amount is included in the 9-1-1 budget for 2021. The next joint advisory board meeting with Bottineau County will be in March at Renville County. Renae will notify the Board when a date is set.
