NOVEMBER 4, 2025

Board convened at 9:00 a.m. Present: Chairman Andy Gates, Commissioner Rick Haman and Commissioner Jamee Hansen.

Sean Mattern, Road Supervisor, met with the Board. The mowing is done. They are servicing the mowing tractors, and then they will be stored at the Tolley Shop for the winter. The Safety Projects are almost done around the County.

Moved by Comm. Hansen, second by Comm. Haman to approve purchasing new voting booths and two display systems for election use. Motion carried by unanimous vote of aye.

Moved by Comm. Haman, second by Comm. Hansen, to remove and discard-item #1215, a label maker in the Recorder's Office from inventory. The item no longer works. Motion carried by unanimous vote of aye.

Moved by Comm. Hansen, second by Comm. Haman to transfer a decommissioned patrol vehicle to the Park, and to send the current Park pickup to the auction for disposal. Motion carried by unanimous vote of aye.

Roger Hutchinson, County Sheriff, met with the Board. He will be ordering a patrol vehicle through Westlie Motors in Minot. Estimated cost is \$53,165.00. Delivery date has not been sent. He has had two applicants for deputy positions. He discussed the Back the Blue grant and how he will propose to use the funds.

Chad Schmidt, Custodian, discussed the heating system with the Board. The furnace is working but he is still waiting for the permanent registers.

Danielle Petersen, County Recorder, asked the Board to approve out of state travel for a trip she won at the NDACo convention. The trip is to attend the National Association of Counties convention in New Orleans in July. Moved by Comm. Haman, second by Comm. Hansen to approve the travel. The airfare, hotel costs and some meals are covered by NDACo. Motion carried by unanimous vote of aye. The Board asked Danielle to get a quote on the cost to finish the back scanning in the Recorder's office. The Board also asked her if she would allow her deputy to work on a project for Mouse River Park online camping registration setup. Danielle was fine with that as long as it did not interfere with Terri's Recorder and Clerk of Court duties.

Julie Vetter, HR Consultant, visited with the Board. She has been doing coaching sessions with Danielle Petersen and Bethany Gates. She also put a HIPPA training program together for the Sheriff's office and wrote a grant to help pay for it. Julie also completed the job description for the Park Caretaker position.
