RENVILLE COUNTY COMMISSIONERS' PROCEEDINGS FOR THE MONTH OF APRIL 2025

APRIL 1, 2025

Board convened at 9:00 a.m. Present: Chairman Andy Gates, Commissioner Rick Haman and Commissioner Jamee Hansen.

The Board discussed the proposal from Warren Lee to update all the Cat 5 cabling in the courthouse to Cat 6. The estimated cost is \$40,161.30. Moved by Comm. Haman, second by Comm. Hansen to move forward with the project. Motion carried by unanimous vote of aye.

Sean Mattern, Road Supervisor, met with the Board. He put the load restrictions on the County roads on March 25, 2025. They have pulled the wings off of the motorgraders, finished painting in the Mohall Shop, painted the trailer decks and have ordered road tar for crack sealing. The new motorgrader should be delivered next week.

The Board discussed the current rates charged by the County for road maintenance. The current rate of \$100.00 per hour has been in place since May 2022. Costs have risen significantly since 2022. Moved by Comm. Hansen, second by Comm. Haman to raise the per hour rate to \$125.00 beginning April 1, 2025. Motion carried by unanimous vote of aye.

Jamie Routledge would like to plant trees across a "closed" section line on his property. He owns both sides of the property. The section line was formally closed May 4, 1983. Moved by Comm. Haman, second by Comm. Hansen to abandon the section line between Sections 15 and 16, Township 158 North, Range 83 West. Motion carried by unanimous vote of aye.

Scott Wheeler had emailed a request for a letter of support for "Lawrence Welk Day" to be declared for July 2, 2025. The Board did not act on the request.

The Board discussed the former Mohall Cityhall building. Moved by Comm. Hansen, second by Comm. Gates to offer \$120,000.00 to Mohall City. The amount to be paid in \$30,000.00 increments over 4 years on a Contract for Deed. Roll call vote as follows: Gates - yes; Hansen - yes; Haman - abstained. Motion carried. Moved by Comm. Haman, second by Comm. Hansen to authorize Comm. Gates to act on the County's behalf at the bid opening on April 8, 2025 with a maximum bid of \$160,000.00. Motion carried by unanimous vote of aye.

Kristy Titus, DES Coordinator, met with the Board to discuss the 2025 burn policy for the County. She has spoken to several fire chiefs and producers within the County. They would like the policy to remain the same as the 2024 policy. The Board will meet again on April 24th and discuss the policy for 2025. They would like to review other counties' policies.

Moved by Comm. Haman, second by Comm. Hansen that the minutes of March 2025 be approved as presented. Motion carried by unanimous vote of aye.

Correspondence addressed to the Board's attention was reviewed and discussed. Travel requests and March payroll were approved as presented.

Moved by Comm. Haman, second by Comm. Hansen to remove and discard wooden chair #335 from inventory. Motion carried by unanimous vote of aye.

The Board asked Auditor Pollman to gather information on possibly changing elected positions to appointed positions.

Board convened at 10:30 a.m. Present: Chairman Andy Gates, Commissioner Rick Haman and Commissioner Jamee Hansen.

Mitch Preskey and Steve Farden met with the Board to discuss load limits on County Road #20. They would like to be able to haul heavier loads from Hwy 83 into Glenburn. County engineer, Jason Mayfield, was present for the discussion. He stated that the County roads are not engineered for the same weights as the State Highways. County Road Supervisor, Sean Mattern, was also in attendance for the discussion. The Board did not act on the request.

Steve Farden discussed starting on the west access road to the Mouse River Park. He would like to start removing the old asphalt and laying down the cement treatment and gravel. Mayo Construction will pave the road but not until September. Farden Construction would have to maintain the road until the paving can be done. Jason Mayfield will speak to Mayo Construction concerning the request.

State's Attorney Seymour Jordan entered the meeting at 11:00 a.m.

The Board discussed the proposals that had been received for the heating system update for the Courthouse. Moved by Comm. Haman, second by Comm. Gates to accept the proposal from 701 Plumbing & Heating. Roll call vote: Comm. Gates - yes; Comm. Haman - yes; Comm. Hansen - Abstained. Motion carried. The estimated cost for 2 new boilers and 42 registers is \$240,556.00.

State's Attorney Seymour Jordan left the meeting at 11:20 a.m.

Jason Mayfield, Wold Engineers, discussed the Notice of Award for the west access road to the Mouse River Park. Low bid was Mayo Construction at \$1,150,704.37. The County was awarded Special Road Funds from the State in the amount of \$137,447.03. Federal Aid funds will also be used for this project.

RESOLUTION 2024-8

Fire Emergency & Burn Restrictions Declaration
For
Renville County, North Dakota

WHEREAS, Renville County, North Dakota has and is expected to continue to endure periods of dry conditions with significant vegetative fuels available; and

WHEREAS, all available resources remain committed to protecting life and property; and

WHEREAS, Renville County has either sustained or been threatened with rural fires in the past and the local Emergency Management Office has been in consultation with local fire departments; and

WHEREAS, the impact of fires could threaten the health, well-being, and safety of the citizens in Renville County; and

WHEREAS, the cost of response, inordinate equipment wear/tear and fire damages may be beyond available Renville County resources; and

WHEREAS, Renville County wishes to regulate activities within the County which pose a potential hazard for such loss, should the present weather conditions continue.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Renville County Commissioners, declares a Fire Emergency and Burn Restrictions (including a ban on the ignition of fireworks, campfires, fire pits, fire rings, recreational fires, burning of garbage, leaves, grass clippings, construction debris, pit burning, fallen trees, and ditches) remain in effect whenever the North Dakota Fire Danger Rating is in the High, Very High or Extreme Status and/or a Red Flag warning has been issued for Renville County, North Dakota.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Renville County Commissioners, declares a Fire Emergency and Burn Restrictions (including a ban on the burning of crop residue, and slough burning) remain in effect whenever the North Dakota Fire Danger Rating is in the Very High or Extreme Status and/or a Red Flag warning has been issued for Renville County, North Dakota.

Crop residue and slough burning will be allowed when the Fire Danger Rating is "High" and NO Red Flag Warning has been issued, with a tilled firebreak encompassing the perimeter of the burn, be in attendance until the burn is completed, and Bottineau Dispatch has been notified of the burn. Any type of road surface is not considered part of the tilled firebreak perimeter.

This policy will remain in effect until rescinded. THE PENALTY FOR VIOLATION OF THIS BURN RESTRICTION IS A CLASS B MISDEMEANOR (NDCC 37.17.1-10.1: MAXIMUM SENTENCE OF 30 DAYS IN JAIL AND A \$1,500.00 FINE). THE RENVILLE COUNTY SHERIFF'S DEPARTMENT IS AUTHORIZED TO ISSUE CITATIONS TO VIOLATORS.

Lawrence Welk Letter of Support

Whereas, July 2nd, 1955 will mark the 70th Anniversary of the national debut of "The Lawrence Welk Show" on television; a show which was aimed at family friendly variety in acts and music which spanned numerous genres such as Country, Jazz, Pop, Polka, and Patriotic.

Whereas, Lawrence Welk, a native of Strasburg, North Dakota took to the national stage values and love for music that started like crops in North Dakota soil and the harvest benefited generations of Americans during times of war and peace, prosperity and difficulty.

Whereas, in North Dakota he was recognized in his lifetime such as being inducted into the Rough Rider Hall of Fame in 1961, awarded an honorary degree by North Dakota State University in 1965. Later, his birthplace, the Ludwig and Christina Welk Homestead where he lived until he was 21 was placed on the National Register of Historic Places, and is today open to the public, and owned by the State of North Dakota.

Whereas many North Dakotans are of full or partial German and/or Norwegian descent, it is noteworthy that Lawrence Welk was of German (German Russian) heritage, and Myron Floren originally from Webster, South Dakota was the son of immigrants from Norway and was himself inducted into the Scandinavian American Hall of Fame in Minot, North Dakota in 1984. Their success stories are among the examples of how far Americans from anywhere in America can go with hard work and perseverance.

Whereas "The Lawrence Welk Show" is still aired regularly across America in a number of states including North Dakota (on Sunday evenings in North Dakota) more than 40 years after its last episode, and more than 30 years after his passing.

Whereas his aim at family friendly entertainment is an example of a worthy goal in any generation as is the idea of bringing together quality from the past and present, and worth of all corners of North Dakota to come together to celebrate.

NOW, THEREFORE, The Renville County Commission hereby proclaims July 2, 2025 Lawrence Welk Day and a day to honor "The Lawrence Welk Show" in Renville County, North Dakota.

Roger found 2 radar units and 6 tasers at ND State Surplus Property. Deputy Jon-Paul Berg will be going to part-time as of June 1, 2025. Deputy McKenna will be done with School Resource Officer duties for the summer, so she will be on patrol. Deputy James Burton will go to full time status this fall.
